THRIVE DC CONTINUED TO PROVIDE DAILY IN-PERSON PROGRAMMING THROUGHOUT THE PANDEMIC INCLUDING BREAKFAST AND LUNCH DAILY; FREE SHOWERS AND LAUNDRY; MAILING ADDRESS, TELEPHONE, AND COMPUTER ACCESS; PERSONAL CARE SUPPLIES; HEALTH AND PPE;

IN 2020, THERE WERE A TOTAL OF 24 PARTICIPANTS IN THE WIND AND NEW DIRECTIONS PROGRAM, WHO HAVE BEEN INVOLVED IN THE PROGRAM FOR 30 DAYS OR LONGER. IN 2020, PROGRAM PARTICIPANTS WERE PRIMARILY IDENTIFIED THROUGH CONNECTIONS WITH BOP AFFILIATED RESIDENTIAL REENTRY CENTERS.

OVER 106 JOB SEARCHES WERE POSTED 17 CLIENTS REPORTED GAINING EITHER FULL-TIME OR PART- TIME EMPLOYMENT. THIS WAS PARTICULARLY DIFFICULT YEAR FOR FRONT-LINE WORKERS WHO WERE LAID OFF, WHO GOT SICK AND LOST THEIR JOBS, OR WHO WERE NOT ABLE TO FIND EMPLOYMENT BECAUSE OF THE CLOSURES.

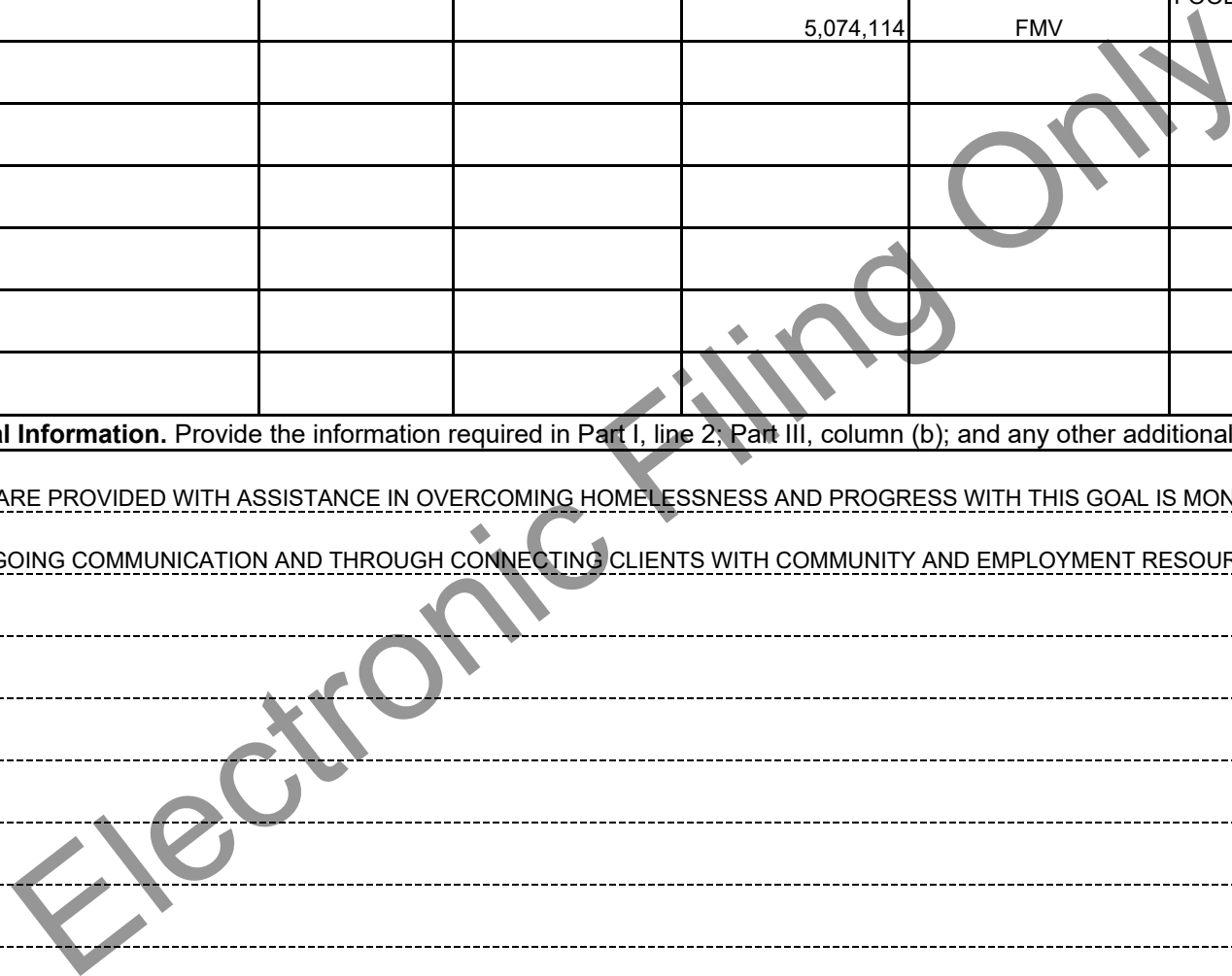
